

Perspectives from the Editor

Prosthodontics 21: "Page 3"

Enclosed in this issue of the AP Newsletter is a copy of George Zarb's editorial "Prosthodontics 21: A new beginning." There is a very important message that compels us to present it with the Newsletter.

The message contained within the editorial is apparent — like a loud crisp bell ringing. Perhaps the sound is inaudible for some who are not prepared to recognize the paradigm shift. Change is in the air — not to discard the proven time-tested techniques, but rather the commitment to a scientific basis for education, research and clinical practice — a process of confirmation. This is not to imply that we have not been scientific in our past efforts.

We must no longer categorize our patients by the treatment rendered. It is time to improve upon the diagnosis and accompanying parameters of care which include: indications for treatment, therapeutic goals, risk factors to the patient and physician, standards of care, and the recognition of variable outcomes. Some will remark that this process is too nebulous and that it defies measurement or scientific scrutiny. Others may recognize that "if we don't do it, someone will do it for us", and they may not appreciate our interests or concerns.

This may readily be seen in the area of health systems reform. The Health Care Financing Administration has established Relative Values (RBRVS) for physician work. There are eleven prosthodontic codes in the Current Physician's Terminology-4th Edition manual. These prosthodontic codes are subject to the RBRVS process. While treatment methods and approaches may vary widely, they are eminently quantifiable. One may quickly visualize the potential impact upon the procedures that we perform.

Fortunately (or unfortunately), this will necessitate that we approach treatment based upon a documentable scientific precept.

The timing of the Prosthodontic Research Symposium could not be better!

The original conception and fostering of the Federation of Prosthodontic Organizations (FPO) and Prosthodontics '21 were an incredible accomplishment. Academy members have been instrumental in the evolution of both. However, the demise of the FPO has created a partial vacuum. We must not allow this opportunity to falter through the natural currents of apathy. The Academy was well represented at the founding Prosthodontic Research Symposium at McMasters University. This speaks well of our organization and serves as an excellent beginning — but we must not rest upon our past accomplishments.



Academy Fellows Outreach in Montana

Billings Indian Health Service

Four Academy members volunteered their time in Browning, Montana August 8-15, 1994. Participants in the project include: the director, Eric Rasmussen from Madison, Wisconsin; Carl Andres from Indiana University; William Kotowicz from the University of Michigan; and Dorsey Moore from the University of Missouri. They were accompanied by a dental assistant, Lonni Roth, and a dental technician, Deb Peterson. The dental facilities were limited and the site was remote. Dentsply and Patterson Dental Supply donated teeth and other materials for this project.

Wayman, dental service chief, welcomed us and made us feel at home. His organization and good will set the tone for the week, noted Dr. Rasmussen. We were introduced to Blackfeet traditions and ceremonies by the medicine man, Buster Yellow Kidney, and were invited to a Great Plains sundance. Also, we attended a sweatlodge ceremony which is a purifying and

renewal ritual that has healing powers for the participants. Our side trips included "The Road To The Sun" at nearby Glacier Park were we saw herds of elk and ate fresh whitefish from Lake St. Mary. In addition to providing dental care to edentulous patients from the Blackfeet Tribe, they also shared their skills and experience with the Indian Health Service staff. We all felt that we received more than we gave and are anxious to return next year.

Approximately \$5,000 for this public service was donated by the AP Foundation.
