Presidential Address



Jonathan L. Ferencz

This Academy places great value on mentorship. The word “mentor” encompasses several definitions including “a wise and trusted counselor, teacher or advisor” and “a guide in philosophical matters.” Some might define a mentor as someone who guides a novice through a process, pointing out the potential hazards to be avoided along the journey. Perhaps one of the finest compliments given in our profession is to be known as a mentor. Academy Fellow Jonathan L. Ferencz embodies all of these definitions. While most members of this Academy are aware of his extensive accomplishments spanning 32 years in practice, few among us realize the achievements that are the hallmarks of both his professional and personal life. Beneath Jonathan’s quiet demeanor lies his passion for prosthodontics, for the life well lived and energy for endless learning. These are some of the distinguishing traits represented by a true mentor as well.

Jonathan was raised in Queens, New York. As a boy, he played baseball and hockey but these favorites were later traded for the sport of cycling. He enjoys a weekend ride whether tackling hills near home or mapping out routes with family and friends. Jonathan’s collegiate years were spent at Rensselaer Polytechnic Institute in upstate New York prior to attending New York University (NYU) College of Dentistry where he graduated in the top of his class in 1971. During dental school, Jonathan met and wed Maxine Clayman, a poised, gracious and articulate daughter of Dr. Lawrence Clayman. Dr. Clayman was a restorative dentist with a fine reputation and a private practice in Manhattan. Following his internship at Montefiore Hospital, Jonathan entered into practice with his father-in-law and joined the faculty of the Department of Fixed

Prosthodontics at NYU. His superb clinical skills and unyielding commitment to excellence are still recounted by his dental school classmates and his students from those early years. There is also the rumor of a nickname “Do-It-Again” Ferencz that continues to be talked about occasionally at NYU!

Academy Fellow Frank Panno was named Chairman of the Department of Prosthodontics at NYU and through his friendship and guidance convinced Jonathan of the value in pursuing additional training in postgraduate prosthodontics at NYU. Already a full time practitioner and father to two young children, this commitment would require four years in a part time program. As Jonathan’s mentor, Frank strongly believed this was the only direction for Jonathan. He even offered to write a check to secure his place in the entering class as Jonathan considered the proposal. To no surprise, Jonathan graciously accepted this challenge with his unquenchable thirst for knowledge. The rest, as is often said, is history.

Following the completion of his prosthodontic training in 1984, Jonathan took on yet another challenge in directing the undergraduate Honors Program in Fixed Prosthodontics at NYU. This program was a highly successful recruiting pathway for budding prosthodontists (the author included!) and quickly gained a reputation for helping to serve as a pipeline for quality candidates for prosthodontic residencies and as a model for other honors programs throughout the country. As someone who had gone back for additional training after 8 years in private “restorative” practice, Jonathan’s passion for prosthodontics coupled with his skills and knowledge made him a convincing spokesperson for the value of prosthodontic specialty training.

While devoting his practice solely to prosthodontics, Jonathan advocated for the strengthening of prosthodontic organizations and brought his unique perspective on issues to the Greater New York Academy of Prosthodontics and the Northeastern Gnathological Society, serving as President of *both* organizations simultaneously in 1995-96.

Not satisfied with just being “a prosthodontist”, Jonathan set another challenge for himself by “completing his postgraduate training” in 1998 when he successfully challenged the American Board of Prosthodontics. Once again, Jonathan’s

The final planning for the 2005 Scottsdale Meeting from May 17 through 21, 2005 is well on the way. Please note the hotel and travel information elsewhere in this Newsletter. The Welcoming Dinner will be Tuesday, May 17 with the Get Acquainted Breakfast and opening Scientific Session on Wednesday, May 18. The Executive Council will meet on Tuesday, May 17. We encourage all of you to invite guests and promote attendance at our Annual Scientific Session. You may visit the Academy's website (www.academyprosthodontics.org) for the latest updates regarding the annual session.

The meeting will be held at the Hyatt Regency Scottsdale at Gainey Ranch. The Hotel is described as comfortable Southwestern elegance in a desert oasis offering a 2.5 -acre "water playground", water slide, sand beach, tennis, championship golf, Sonwai Spa, Camp Hyatt Kachina, Native American and Environmental Learning Center, Native Heritage Seed Garden Native American Sculpture Garden, international art collection and four distinctive restaurants. There is a full service spa on the property. The room rate is \$235 per night. This is well below the going rate for this magnificent environment. You are strongly encouraged to stay in the Hotel as we have a financial obligation.

Academy of Prosthodontics Meeting. Local Arrangements Chair, Lisa Lang, has been organizing the local arrangement details. We are planning a single group outing again this year, and the schedule will actually allow for some free time. Our outing will be on Thursday afternoon at "Taliesin West." This was the winter camp of Frank Lloyd Wright and an experience to see. The bus ride is approximately 25 minutes.

The preferred arrival and departure airport is the Phoenix Sky Harbor International Airport (PHX). It is approximately 20 minutes from the Hyatt Regency Scottsdale Hotel. Cab fare is approximately \$35 each way. There is also an Executive Car Service available by calling 602-232-4822. This service runs about \$45 each way.

Dr. Goldstein has been hard at work with the Program and the Annual Scientific Session will run from Wednesday, May 18 through Saturday, May 21. We are all in for a treat. The evidence based dentistry session will be on ceramics. The Program will end at 1:00 PM on Saturday, May 21. Our Annual Business Meeting will immediately follow it. The Business Meeting is scheduled to end at 4:30 PM. Please do not plan departure from the Hotel before 4:30 PM on Saturday. It's an incredible environment; you may want to consider staying until Sunday. In response to the request of membership, exhibitors will be limited to just two mornings - Thursday and Friday.

The 2004 fiscal year was a success for the Academy and significant resources have been added to the Academy's reserves. A full report will be presented at our Annual Meeting. However, concern looms for the 2005 meeting. The commitment to the hotel and social events are considerably greater than for Niagara. The Niagara venue was cost effective due to the Canadian loca-

tion. In addition, 2005 will be the first year that an Annual Scientific Program Budget will be in affect. Expenses will be higher and there is concern about decreased revenues due to fewer guests. The efforts of Roy Yanase and the support of our Corporate Sponsors will help offset the higher expenses.

Everyone should have received his or her dues statements. The dues include the subscription to the Journal of Prosthetic Dentistry. The dues also included a mandatory advanced meeting payment of \$250 for all Active and Associate Fellows (does not apply to Life Fellows). The \$250 will be credited toward their social events expense if members register in the hotel room block by the published deadline (May 2, 2005). The fee is not refundable (no portion of it). The Academy of Prosthodontics Outreach Program: Past Accomplishments and Future Directions

In 1995 in Crystal City, VA the Executive Council of the Academy revisited its goals and objectives and developed a mission statement that serves us today. “The Academy’s mission is to promote the art and science of the profession to the public, to disseminate knowledge throughout the profession, to encourage study and investigation of the various phases of prosthodontics and related subjects, and to provide and conduct outreach services to the community in need”. This last phrase helped to establish a Community Outreach Committee. The Executive Council made a firm decision to provide volunteer prosthodontic services to a population that demonstrated extreme need. Fellows familiar with the Indian Health Service (IHS) suggested this type of care as a possibility and a proposal was made to the IHS for volunteer prosthodontic care. There was immediate response from The Carl Albert Indian Health Center in Ada, OK. The staff prosthodontist informed the Academy that there was a population of nearly three thousand patients that had to wait more than three years to get an appointment for denture service. In August of 1993, 8 Academy Fellows and 1 guest technician were invited to provide clinical denture care to 30 patients. Sixty complete dentures were completed in one week with help of their very dedicated dental technicians. As news of the Outreach Committee’s work spread throughout the IHS network more requests were made to the Academy for inclusion in the projects.

Volunteers

Recruiting volunteers has been a rewarding experience as the Academy has demonstrated the force Fellowship can bring to bear on community service. The current arrangement for one week denture projects is to have three prosthodontists and three dental technicians provide denture care for 12 -20 patients. To this date, 31 Fellows have participated directly in the project. Seventeen guest dentists and graduate students have helped in clinical and laboratory procedures. Thirteen technicians have served us in a very dedicated way.

Each new volunteer in the projects allows this Fel-

lowship experience to spread through the organization. Many Fellows have responsibilities in other areas of prosthodontics and can’t always join outreach teams due to conflicts in their schedules. Some Fellows can’t participate directly but are generous in their encouragement and financial support. Other Fellows arrange procurement of new and used dental equipment for use at projects sites.

Funding

Initially, the entire expenses of the outreach projects were borne by the Academy of Prosthodontics Foundation. The seed money came from the Academy Foundation, the Editorial Council of the Journal of Prosthetic Dentistry, and donations from individual Fellows of the Academy. The generosity of private foundations has helped us begin and continue these denture clinics. Private donations have had a significant impact on the ability for the projects to occur at multiple sites but usually these grants have a limited time frame.

Private Industry Donations

Many dental supplies are needed to produce complete dentures. Large dental supply companies have been generous to the Outreach Committee for a number of years. Ivoclar International is providing us a number of teeth for these projects and their generosity is appreciated. Miscellaneous supplies have been provided to outreach projects by dental supply houses at their cost, which has also helped to offset the cost of funding these projects.



Travel Expenses

Travel is the largest remaining expense for outreach projects. Some participants in the teams have donated tickets and frequent flyer miles to aid in containing the costs of these projects. During the last year, an Assistant Secretary at IHS in Washington D.C. suggested that because the Academy is

providing volunteer service to IHS clinics, these clinics are eligible to request invitational travel expenses reimbursement from IHS for members of the visiting outreach team. This will be a new area of committee investigation.

SUMMARY

During the past 11 years, 7 Indian Health Service clinics and 1 urban site in 6 different states have been visited; 29 individual projects have been performed serving 474 patients and providing 871 individual prostheses.

Value

The value of the projects can be calculated in any number of ways; the financial impact on the individual sites is significant since they would not be able to provide this type of service with their present budgets.

The value of the service to the individual patients is intangible, however; the teams' observations indicate there is a great boost in morale to the individual patients, their families and their communities.

Our gratitude

The Outreach Committee sincerely thanks the IHS and its employees for their generosity. We extend our gratitude to the technicians, guest dentists and graduate students who have helped us. We especially thank The Dorothy Snyder Foundation for generous financial help over several years, and finally thanks to the AP Fellows who participate and offer their support in other ways.

As an organization we are developing a model for a partnership between federal health organizations, private industry, non-profits foundations, and prosthodontics. We look forward to continuing the projects, expanding our services, and helping others to see this is as a worthwhile effort.


example and mentorship helped jump-start late-career attempt at Board certification among the large and closely-knit New York prosthodontic community. Often at 6:30 AM (before starting a usual day with patients at 7:00 AM) Jonathan can be found in our office sitting down reviewing Board patients with hopeful candidates and graduate students.

With Fellowship behind him, Jonathan served as President of the American College of Prosthodontists in 2002-03, while maintaining a full-time prosthodontic practice. His service to the College and our specialty is significant for his spearheading the idea that we all need to “give back” to our specialty, as he helped the ACP “New Vision Campaign” raise an unprecedented \$5 million. 
Dr. Bill Laney
