EC decided to hold aspiring and Associate Fellows as speakers until the San Diego meeting so that they can present in person. Likewise, Fellows who were voted on at our last Business Meeting in Banff will be installed in person. In his recent e-mail, Dr. Barzilay also shared the EC's rationale for holding the voting for all aspiring and Associate Fellows until we can reunite and re-establish personal relationships. However, voting for life membership will occur online through the website in advance of the meeting with the results announced at the virtual Business Meeting.

Poster presentations by prosthodontic residents will return virtually under the leadership of Fellow Cortino Sukotjo, Poster Session Chair. Judging will occur on May 20, 2021 the day prior to the meeting, and posters will be available for viewing the same day. The Editorial Council for *The Journal of Prosthetic Dentistry* is providing monetary awards for posters in the research and clinical categories which will be presented on the second day of the program.

As fellowship is a hallmark of the Academy, we are hosting a virtual wine tasting and social hour after the program on the first day of the meeting. Dr. Arun Sharma has arranged for a wine tasting hosted by

Lambert Bridge winery and an opportunity to purchase the wines we will be tasting (see accompanying information). After the tasting, registrants will be moved to smaller chat rooms for fellowship and interaction. Similar to the seating arrangements at the Blatterfein Welcome Dinner, chat rooms will allow Life Fellows and Fellows to reconnect and to welcome guests to the Academy. Even if you don't purchase the wines, please plan on joining a chat room. We all remember attending our first AP meeting as a guest and meeting the giants in our specialty. We want that experience to continue this year with our guests, especially the prosthodontic residents who will be attending.

The Annual Business Meeting will be held one hour before the second day of the program. In order to be as efficient as possible during the meeting, materials will be sent to Fellows in advance of the meeting to review. The meeting will be chaired by Fellow Jack Gerrow to keep us focused and on schedule. As previously mentioned, there will be no fellowship vote. The focus will be on standing reports, election of officers, and selection of the 2023 place of meeting. With the cancellation of this year's meeting in Denver, RES was able to negotiate our return to Denver in 2024 will little increase in cost while minimizing our risk in cancelling the meeting this year.

Resolutions. They are focusing on two major projects initially. First, they are finalizing the memoirs project initiated by Fellows Brien Lang and Jonathan Wiens in preparation for our centennial meeting. The goal is to have 100% participation by AP Fellows. To date, there has been a significant participation by the majority of Fellows. We are missing memoirs from a few Fellows and are encouraging everyone to participate. While we appreciate the hesitance of some members to "toot their horns" rather, consider this an opportunity to acknowledge and thank those AP Fellows who served as mentors and guided you along the way. Each of us has such a story!

Over the years the AP has recorded interviews of its Life Fellows. Fellows Jon and Keith Ferro have begun the Herculean task of editing the interviews. In addition to reading the published works of our Fellows, future generations will have the opportunity to hear from them directly. What a gift this will be for our Academy and specialty! Secretary-Treasurer Notes By Mijin Choi



As I write the 2021 spring edition of the newsletter, we have passed the one-year mark since the COVID-19 pandemic. All of us had to change our ways of doing things. Moreover, we succeeded in making the necessary changes quickly and effectively with careful deliberations and collaboration of all Executive Council members.

In November of 2020, the Executive Council of the Academy held the first virtual November Interim Meeting. During the Interim Meeting, the motion to hold all Executive Council members' current positions for an additional year was unanimously carried as there was no AP business meeting in 2020.

With the 2020 Asheville meeting's cancellation, the 2020 AP meeting registration fees were refunded to nearly all Fellows. Also, the majority of the sponsors for 2020 meeting requested refunds. One sponsor

allowed sponsorship to roll over to 2021. With these changes, the Academy had a small amount of surplus in the fiscal year 2020.

In December of 2020, our nation was still in the middle of the COVID pandemic without clear information on COVID vaccination status and its rollout plan. The Executive Council was facing a difficult decision on the upcoming 2021 Denver Meeting as the Academy was in a binding contract with the Four Seasons Hotel in Denver. Multiple budget scenarios were developed to assess the financial impact. At one-half of the usual attendees with limited available sponsorships, the Academy could potentially have a significant financial loss. The Executive Council and RES began communicating with the Four Seasons Denver to find ways to minimize potential financial loss in the event of meeting cancellation. After the extensive renegotiation efforts, a minimal increase in contract terms reflecting the anticipated general 2024 inflation was achieved without additional deposit requirements or loss of the deposit. The Executive Council's collective efforts and RES's dedication to protecting the Academy's financial future resulted in the positive outcome. The Executive Council extends special thanks to RES for their hard work and commitment to the Academy.

Immediately after deciding not to hold the in-person Annual Meeting, the EC began to formulate the 2021 Annual Virtual Meeting. The virtual Annual Meeting will be managed by virtual meeting production companies and the RES team behind the scenes, in this case behind the web platform!

I am also happy to report that RES and the EC agreed to extend our collaborative endeavors in upholding and growing the AP's traditions for the next four years.

Looking forward to 2022, President-Elect Dr. Lisa Lang will be welcoming you in San Diego, CA. Dr. Lang and Dr. Barzilay will be presenting a glimpse of the much anticipated in-person annual meeting. At the upcoming business meeting, we will also be discussing the AP 2023 Meeting site scheduled for the east coast. Dr. John Sorensen, who will be the President of the 103rd Annual session, will lead the discussion.

Working through the unknown virtual meeting territory, the AP had to make difficult decisions and adapt to the new norms. We, as the AP fellows, lost the opportunity to re-affirm our fellowships in person. However, it was also an opportunity to witness your support and trust in the Academy's leadership. With much anticipation, we await seeing all of you in your neck of the woods virtually.

This has also profoundly affected our traditional annual session.


The foundation of our Academy meetings are the scientific sessions

Despite being a virtual format, we believe that the Academy will deliver an exceptional 2021 annual session. We have drawn on a significant contingent of our world-class Academy Fellows as well as experts from academics, dental technology, various specialties and industry, all aimed at advancing our knowledge base, promoting intellectual discourse, inspiring clinical excellence and looking to the future.

Our folks at RES found an outstanding virtual platform company that provides many features to help us create a more live and interactive experience despite being virtual meeting. Consistent with our Academy of Prosthodontics traditional meetings of

He was the Chancellor's Eminent Professor of Chemistry at the UNC Chapel Hill, and the Kenan, Jr. Distinguished Professor of Chemical Engineering at NCSU and of Chemistry at UNC.

It was probably the most fascinating lecture I have seen in decades. With over 4 million views, DeSimone's TED2015 talk on *What if 3D printing was 100x faster?* introduced his group's revolutionary technology development.

In 2015, DeSimone and colleagues published a paper in Science Magazine on their invention of a rapid polymer 3D printing technology, *Continuous Liquid Interface Production* (CLIP). The company, *Carbon*, which DeSimone co-founded, now develops printers with the CLIP technology. Called a *Tech Unicorn* by Forbes magazine, their printers are used by companies such as Adidas, Resolution Medical, Ford and Carbon for dental products.

DeSimone has published over 350 scientific articles and has over 200 issued patents in his name with over 200 patents pending. He currently serves as Carbon Co-Founder and Board Chair and holds the titles of Professor, Department of Radiology, School of Medicine, Professor, Department of Chemical Engineering, Professor, Graduate School of Business (by courtesy) at Stanford University.

Next, Dr. Stephen Chu will continue on the road of invention, presenting a highly innovative novel biologic dental implant design and offer his approach to Risks, Complications, and Solutions in the Esthetic Zone: A Paradigm Shift.

Digital Masters- Materials, Design, Technology & Software

We have witnessed an unprecedented rate of development and evolution of materials, design, technology and software in prosthodontics. Four global thought leaders, visionaries, inventors and innovators who have been on the cutting edge both in dental technology and prosthodontic practice for decades, will present their perspectives in this rapidly developing area. These luminaries include Mr. Lee Culp, Mr. Don Cornell, Mr. Vincent Fehmer and Dr. Jonathan Ferencz.

Day 2 of our program will be devoted to *Risk Assessment*.

Perhaps the most challenging mission in clinical practice is the decision-making process in patient assessment, diagnosis and treatment planning with the goal of maximum longevity of periodontium, implants and prostheses. We will ask our specialists from 3 continents in periodontics (Drs. Richard Kao and Guo-Hao (Alex) Lin), prosthodontics (Drs. Danielle Layton and Carlo Ercoli) and material

One on One with Christoph Hämmerle

Professor Christoph Hämmerle was born in the small municipality of Steffisburg in Switzerland. His dedication and contribution to Prosthodontics has certainly been mountainous. Professor Hämmerle's love for

science, mentorship and travel has shaped his career.

Family has had a strong influence from the beginning of his career. Prof Hämmerle's father was a local dentist whilst his grandfather was a school teacher in a rural village for over 40 years. The family traveled a lot when he was growing up and this is something he has continued throughout his adult life. Unfortunately, his father passed away when Christoph was a teenager, so his mother was his sturdy role model. She imparted the importance of personal strength and responsibility alongside friendship and exploration. Growing up, their house was always full of friends whilst weekends were often spent outdoors in the mountains. His travels even included an exchange year in high school in Grand Haven, Michigan.

Prof Hämmerle started his dental training at the University of Bern. It was there that he was first

introduced to Klaus Lang, one of his inspirations. Periodontics and prosthodontics were the fields which were taught from a scientific perspective. He felt the strong basis of evidence-based treatment planning, alongside fundamental biological basis for disease control and stabilization. The perio-prosthodontic teachers were by far the most impressive in the school and his interest in perio-prosthodontics followed their scientific approach.

In 2000, Prof. Hämmerle was appointed chairperson of prosthodontics in Zurich following Prof. Peter Schärer. During the initial time period, he greatly expanded his clinical knowledge and skills from the excellence that had been developed in the prosthodontics department in Zurich. He has strived to amalgamate clinical and scientific concepts from both dental Universities in Bern and Zurich into his teaching and research.

Klaus Lang was one of Prof. Hämmerle's most influential mentors, who guided him and was an inspiration in the world of academia. H-P Weber was a dedicated teacher and example that he looked to emulate. James Winkler provided helpful advice for navigating the machinations of a career in dental academia and Tom Taylor acted as a resource person for advice and direction. Beat Kehrli was Prof. Hämmerle's principal when he went into general practice for 3 years before starting perio-prosthodontic

training. He set a fantastic example of understanding patients and providing dedicated care.

Christoph has two daughters and a son. Daniel works in IT concept development, whilst Fabienne is studying social sciences and Tiffany is an event manager in a technology cluster. Prof. Hämmerle's siblings varied professionally from an HR lawyer to nuclear engineer to international affairs.

Outside of dentistry, Prof. Hämmerle loves sports. He was a keen handball player, skier, and a regular hang glider. More recently, Christoph and his wife of 11 years, Corinna, enjoy golf alongside hiking and he loves being on the open road on his motorcycle.

Christoph's love for travel has taken him to all corners of the world, but he is particularly happy in that he has managed to experience dentistry in different continents. He has spent time in dental institutions in San Francisco (USA), Santiago (Chile), Mendoza (Argentina), Pune (India), Sydney, Brisbane (Australia) and Beijing (China). Furthermore, he contributed to an outreach in Lambarene (Gabon).

Prof. Hämmerle's honors include Specialist certificates in Periodontology, Prosthodontics, Oral Implantology; Doctor honoris causa from the National and Kapodistrian University of Athens;

Honorary Member of the EAO and the Osteology Foundation; Jerome M. and Dorothy Schweitzer Research Award from the GNYAP.

Christoph is particularly proud of his achievements in teaching, clinical research, improving patient care, and outcomes. Under his mentorship, he has supervised over half of the Prosthodontic specialists in Switzerland since 2000 and has had 7 students complete their PhDs; 3 of whom have progressed to become professors in their own right. His international collaborations have enabled more than 25 students from around the world to have spent a year under his teaching.

Prof. Hämmerle is quoted as saying, "Life has no scientific controls. One has to live by values of honesty, respect, and teamwork". These are values that go hand in hand with the Academy of Prosthodontics.

Outreach to Price, Utah

This past August, a team consisting of four graduate students from the Advanced Specialty Education Program in Prosthodontics, at the Loma Linda University School of Dentistry (LLUSD) and two Academy Fellows, headed to Price, Utah to meet up with Academy Fellow Dr. Paul Martinez for the Academy of Prosthodontics (AP) Outreach (Figure 1). The planning process had begun in early 2019 when the team members were selected and coordinating began to determine the appropriate location and time. Price was determined to be the best city to conduct this first outreach for the team from Loma Linda. Dr. Kattadiyil and Dr. Martinez arranged clinic time and patient appointments from August 12- 15, 2019.

Early in July, responsibilities were distributed, to ensure that everything would run as smoothly as possible. On August 11, the team members gathered to depart from Salt Lake City Airport. It was a beautiful car ride from the airport to Price. It was an amazing experience to take in the beautiful views of Salt Lake City. Upon arrival, the team visited the clinic the same day to check the available materials and infrastructure and to familiarize themselves with the clinic setting for a busy day ahead (Figure 2). Dr. Martinez informed the team that he had selected nine patients, most of whom were completely edentulous or required extraction of remaining teeth.



The team arrived early morning at the clinic and met Dr. Martinez's wonderful staff who had already arranged for all the patients to arrive at specific time intervals. The team separated into two groups; one



group worked in the clinic. This group interviewed, examined the patients and made preliminary impressions. These impressions were poured up, followed by custom tray fabrication by the second group in the lab. In some situations, final impressions were made with the customizable trays invented by Dr. Wagner and it was a special treat for the LLUSD graduate students to work with Dr. Wagner himself. Jaw relation records were made the same day for most patients and a few anterior teeth trial placements were done.

The team completed jaw relation records and most teeth trial placements on the second day. After patient approval for esthetics, students and faculty, working late into the evening, did final festooning. The remaining trial placements were completed the following day. The trial dentures were sent to a local laboratory for processing. The team had the opportunity to complete placement for two patients and we were informed that the laboratory would need additional time for the remaining.

The students experienced firsthand the tremendous impact on each patient when trial placements were completed. Patients were thrilled to have 'teeth' and many expressed their appreciation for the hard work that was dedicated to bring their smiles back.



By the end of the Outreach, the team completed trial placements for all patients and placed dentures for two patients (4 units). The students were motivated to not skip steps in complete denture fabrication (Figure 3); they even took pride in taking photographs with appropriate background and lighting. Dr. Martinez placed the remaining dentures the following week, and he reported they were placed successfully and even sent post-placement smile photographs as he had seen the students were keen on viewing the results (Figure 4).




